

# New Apprenticeship Off-the-Job Training (OTJ) Requirements – August 2025

Be clear on what is needed.



From **August 2025**, the Department for Education is making a significant change to apprenticeship delivery by introducing **fixed minimum off-the-job (OTJ) training hours** for every apprenticeship standard.

## **Key Facts for Employers**

**Minimum 187 hours**OTJ training for any apprenticeship

Minimum programme length: 8 months

No more working pattern calculations – requirements are fixed and simple

## What's Changing?

Previously, apprentices were required to complete at least **6 hours per week** of OTJ training, calculated around their working hours.

From the **2025–26 funding year**, this will be replaced with **set minimum OTJ training hours** for each apprenticeship standard, regardless of the apprentice's working pattern.

#### This means:

- X No more % calculations based on contracted hours
- One consistent training requirement for all apprentices
- ☑ Greater flexibility in how and when training is delivered as long as the **minimum** duration is met
